### **Overview**

CNA is a leader in security sector assessment, monitoring, and evaluation (AM&E). For more than 15 years, CNA has assessed partner nation military and security forces and evaluated operational and strategic outcomes of US security cooperation and assistance programs for US government agencies, including the Department of Defense, Department of State, and US Coast Guard.

## **CNA's AM&E Approach**



#### Rigorous, data-driven analysis:

CNA's empirical analysis, field research to collect primary source data, and proprietary tools help decision-makers understand how programs, policies, and other factors affect progress toward the achievement of objectives.



#### **Country and regional expertise:**

CNA's study teams merge deep country, regional, and security sector knowledge with technical expertise in evaluation, statistics, and mixed methods approaches to provide nuanced, relevant, and actionable findings and recommendations. Field work has taken CNA analysts to more than 30 countries spanning every region of the globe to conduct AM&E on competition, institutional capacity building, maritime and border security, and counterterrorism.
