# **CNA After-Action Reviews: Equipping Justice Agencies for Critical Incidents**

### WHAT is a post-incident analysis?

A post-incident analysis (also commonly termed "afteraction review" (AAR) or "critical incident analysis") is a structured process conducted to evaluate and document the outcomes and lessons learned from specific events or incidents so that agencies can improve for the future. To conduct this type of analysis, CNA uses its ADEPT™ process, a framework for critical incident analysis that encompasses several key stages (right). Entities may conduct AARs at various levels, including independent entities, local jurisdictions, and regional partners. The scope of an AAR may be limited to one aspect of the response or encompass the entirety of the response. In addition, a single-incident AAR might focus on a particular event, whereas a larger meta-analysis of an agency's AAR library might focus on an organization's entire history to help consolidate lessons learned and implement corrective actions.

### The **ADEPT**™ Process



### **SCOPE**

Define the purpose, objectives, and outcomes



### **COLLECT**

Identify data sources; implement data collection plan (including workshops, interviews, document



#### **ANALYZE**

Compile, deconflict, analyze, visualize, and validate data



#### **SHARE**

Document and refine findings; share with stakeholders



### ACT

Develop and monitor corrective actions; support implementation as needed

### WHY should your agency conduct a post-incident analysis?

CNA's post-incident analysis empowers agencies to accomplish the following:

- Reduce risk and liability through independent critical incident reviews grounded in national standards and best practices.
- Accelerate reform and readiness by consolidating and evaluating corrective actions from various responses and agencies to identify common lessons learned and model corrective strategies.
- Enhance jurisdiction, agency, and officer preparedness and organizational learning via virtual training.

## WHO should engage in post-incident analysis?

Post-incident analysis is an important step for a wide range of justice organizations and agencies at all jurisdictional levels and of all sizes and types (e.g., small, large, rural, urban). Agency types include local (city and county), tribal, state, and federal law enforcement agencies; correctional agencies; and probation and parole offices. Entities engaged in developing justice-focused AARs may include oversight boards, local governments, response partners, community services providers, and community stakeholders.
