



# Futurescape of Justice: Helping Your Agencies and Partners Plan and Prepare for the Future

CNA understands that justice agencies and their partner organizations are often inundated with their daily responsibilities, leaving limited time or ability to focus on the future. We help agencies engage in creative and collaborative long-term planning using a futures analysis framework built on CNA research.

### What is the Futurescape of Justice?

The Futurescape of Justice is an innovative initiative developed by CNA's Center for Justice Research and Innovation aimed at assisting justice agencies and their partners in proactive futures planning. Rather than trying to predict the future, CNA's futures planning approach focuses on examining social, technological, economic, environmental, and political (STEEP) factors to help justice agencies identify potential risks and opportunities for success. Through a customized workshop, CNA guides agencies in interactive discussions to understand future trends and develop actionable strategies to address them. This approach not only supports agencies in mitigating risks and promoting success but also positions them as thought leaders in the field of justice.

## WHY should your agency engage in futures planning?

Engaging in CNA's futures planning offers numerous benefits for agencies and their partners, including the following:



#### Identifying future risks and opportunities.

We guide agencies in anticipating and preparing for trends and challenges that may emerge in the next 10 to 15 years using a research-based scenario tailored to the jurisdiction.

## WHO should request futures planning?

Justice agencies and their partner organizations, including local and regional partners; representatives from municipal courts, corrections, city or county government agencies; and community stakeholders, should consider futures planning. Participants may represent various levels of these organizations, from executive to line-level staff.

# **HOW** can **CNA** help your agency with futures planning?

CNA offers two levels of futures planning:

- Futures workshop: CNA conducts an onsite half- or full-day futures workshop. Before the workshop, CNA works with the host agency to customize the agenda and discussion items, identify appropriate participants, determine desired outcomes, and coordinate other logistics. Following the workshop, CNA delivers a summary report on workshop findings and recommendations for planning for the future.
- **Putures workshop with follow-on action planning and implementation support:** In addition to the onsite workshop, CNA can develop interactive dashboards for supporting futures planning implementation and provide training or operational support for acting on futures recommendation.
